## What is TTTF?

The IATA Time and Temperature Task Force, officially created in 2008, develops and maintains standards for the procedures, documentation, cargo handling, packaging and acceptance of healthcare goods.

There are currently 30 official members representing various global stakeholders from the overall healthcare supply chain: cargo and passenger airlines, freight forwarders, third-party logistics providers, specialty couriers, airports, healthcare companies, aircraft manufacturers, international/governmental organizations, packaging and temperature device providers.

By setting international standards and uniform procedures for the air transportation of healthcare shipments, the task force works to ensure the quality of air shipments and to raise the profile of the air transport industry. Temperature excursions, damages, long delays and lost or stolen products are among the main concerns of healthcare shippers.

A major milestone of the TTTF was the addition of Chapter 17, entitled “Air Transport Logistics for Time and Temperature Sensitive Healthcare Products” as part of the IATA Perishable Cargo Regulations (PCR).

Another important initiative was the IATA time and temperature sensitive label that became effective in July 2012 for healthcare shipments booked as temperature controlled cargo.

## What is TTTF scope?

Establish and maintain a time and temperature quality management system by means of a documented process.

Liaise with all stakeholders from the health care industry or their intermediaries in order to establish common standards.

Produce, develop and implement guidance material to maintain drug quality and efficacy when shipping time and temperature sensitive pharmaceuticals.

Being the coordinating body between IATA and the pharma industry for the healthcare logistics forum during the World Cargo Symposium.

Promote its activities with industry associations and shippers.

Lobby government agencies, intergovernmental organizations, stakeholders, carriers, shippers and their intermediaries towards the recognition and adoption of these standards.
